SECOND WORKPLAN: NATIONAL ANTI-CORRUPTION PROGRAMME – JOINT PROGRAMMES

INTRODUCTORY REMARKS

The Implementation Committee met on numerous occasions to consider finalization of the National Anti-Corruption Programme (NACP). The committee has agreed to present this programme, which focuses only on joint projects. Progress on sector-specific projects relating to other resolutions will be reported on a regular basis to the NACF during scheduled meetings. The approach of a select number of joint projects has taken into account the need for the NACF to be once again modest in proposing a NACP. This is largely due to the limited capacity within the NACF. It is a continued belief that fewer projects will ensure better focus and increase the potential for success. All sectors remain committed to the goals and resolutions of the NACF. The Implementation Committee has identified key areas of priority in the fight against corruption and believes that it would be more appropriate to tackle a few high quality projects, campaigns and initiatives rather than commit itself to a long list of projects that the NACF will not be able to deliver on.

Many of the resolutions adopted at the Summit impact on various projects already being implemented at a sectoral level. Each sector has its own reporting mechanisms for these projects. For this reason, this NACP focuses only on joint-projects.

The Implementation Committee is therefore pleased to present the following draft National Anti-Corruption Programme:
